

# COVID-19 Vascular Forum Meeting #2

## HIGHLIGHTS

### System Planning Updates

- All meeting materials and related resources continue to be posted and updated on the [CorHealth COVID-19 Resource Centre](#)
- In follow-up to the discussion from the March 25<sup>th</sup> Forum, further information from the Ontario Hospital Association (OHA) was provided on physician cross-credentialing:
  - The OHA indicated that they are developing, together with the Ministry of Health (MOH), recommendations to expedite usual physician cross-credentialing protocols. CorHealth will post information received from the OHA on the Resource Centre.
  - **Question:** *How should expenses be submitted/documented by providers?*
    - Hospitals will be responsible for submitting COVID-related expenses and therefore providers should track and manage expenses using existing hospital expense-related practices and policies
    - The MOH/Ontario Health (OH) will provide further information when available.

- **Question:** *Is cross-credentialing/the movement of providers mandatory or voluntary?*
  - It is currently voluntary and it is more likely that patients would move around the province rather than providers, but agencies are trying to put policies in place now should this be required in the future.
- Ontario Health has released a guidance document – [OH Guidance - Clinical Triage Protocol for Major Surge in COVID Pandemic \(March 28, 2020\)](#)
  - CorHealth can arrange for Dr. James Downar (The Ottawa Hospital) to speak to these resources if there is interest from the Forum participants.

- Dr. Nagpal reviewed the Vascular Memo developed from discussion during the March 25<sup>th</sup> vascular forum meeting

### **Capacity Planning During & Post-COVID-19**

- Mirna Rahal, Sr. Director, CorHealth reviewed public health unit-level information about the impact of COVID-19 on hospital bed utilization and the potential impact on expected vascular urgent/emergent hospital bed requirements.
- She also reviewed the estimated impact on vascular wait list volumes related to postponement of non-essential vascular activity.
- Forum participants shared agreement that this information will be valuable particularly when planning for resumption of full vascular activity post-COVID.
  - **Question:** *Is the data in real-time for the vascular bed counts?*
    - CorHealth is using DAD data for the total hospital bed counts and other data sources to try and estimate the bed utilization of vascular patients
    - CorHealth is investigating availability of other data sources to provide real-time bed utilization of COVID-19 patients
  - **Question:** *How are step-down beds captured in this work?*
    - For now, step-down beds are captured as ICU beds in the DAD data.

### Telehealth/Virtual Care Resources and Supports

- CorHealth has posted resources on the COVID-19 Resource Page to help support the use of telehealth/virtual care, including changes to the Schedule of Benefits for Physician Services in response to COVID-19 pandemic.

- Dr. Heather Cox noted that the OMA would be sending out a member update about recent changes to telemedicine/virtual care OHIP billing for providers (i.e. billing for phone call appointments).
  - CorHealth will also post this update to the COVID-19 Resource Page.

### Questions/Open Discussion

- Forum participants shared updates on the current status of in-hospital activities in their regions
- Themes included:
  - Concerns over the use of PPE / different approaches to use
  - Most clinic consultations are occurring with use of virtual platforms
  - Vascular OR time is minimal, and, in many hospitals, vascular services is quiet. However, many forum participants suspect that an increase in COVID patients will occur in the coming weeks.
- Many participants felt that the open dialogue portion of the Forum is most useful to share information about how programs are managing
- It was also noted that the Forum will be particularly useful following the active COVID-19 period to maintain open communication for the management of the backlog of elective patient procedures that had to be delayed/cancelled
