<u>Do not fax the cath-referral form to the Provincial Office but directly to one of the contacts at a cardiac centre listed above.</u>

The CCN registry for cath-lab services was inaugurated province-wide on April 1, 2000 and benefits of the expanded registry include:

- improved waiting-list management for patients;
- a smoother referral process for referring physicians;
- consolidation and improved organization of patient-management services for cardiac centres and staff;
- better information for government on health-system performance and needs.

The consistent use of the cath-referral form will help ensure that all necessary information is collected for the cath-lab patient registry, including the urgency rating score (URS) to aid in prioritizing patients. Having one provincial referral form for all centres will simplify the process across the province. (Note: A similar, but different, form is used in Hamilton and Ottawa.)

Is the form mandatory?

Yes. As of April 1, 2000, cath referrals will not be processed by cath centres without a completed form, whether or not supplemental documentation is provided. Incomplete information may result in delays in processing the referral. A new referral form was distributed in July 2012. Previous versions of the form should be destroyed as they cannot be accepted by the registry.

Where to get the form?

A copy of the new form has been faxed by CCN to all referring physicians and forwarded to hospital ICU/CCUs. The form should be saved and photocopied as needed. If necessary, new originals of the form for photocopying can be requested from Regional Cardiac Care Coordinators in all cath centres. (Note: Physicians referring to Hamilton and Ottawa can obtain the correct form directly from those centres.)

Remember!

- 1. Indicate on all referrals for a cath procedure whether a consultation regarding subsequent management of patient care is required.
- 2. After submitting a referral, notify the cardiac centre of any change in the patient's condition.
